

Carroll Village Council met in regular session on Tuesday, June 14, 2022 at 7:00 p.m. Mayor Edward Drobina called the meeting to order with the Pledge of Allegiance.

### **Roll Call**

Members of Council present were Linda Dattilo, Preston Barringer, Will Burns, Kenny George, and Conda Jones. Adam Tippet entered the meeting late.

### **Approval of Agenda**

Linda Dattilo made a motion to approve the agenda, seconded by Preston Barringer, roll call was all in favor.

### **Visitors**

Visitor present were Lacey Kraner from the Carroll Community Festival and Zachary Verley Bloom-Carroll FFA AGVenture Camp.

### **Visitors Comments**

Zachary Verley came to speak about AGVenture Camp. They currently have 118 campers. There will be a different theme for each day. Zachary requested the village to donate money, again, this year. The money would go towards food and supplies needed for the camp. Zachary asked for a motion for council to approve \$1,000.00 donation. Linda Dattilo made the motion to approve \$1,000.00 donation, seconded by Conda Jones, roll call was all in favor.

Lacey Kraner is the President for the Carroll Community Festival. She came to council to present dates, road closures, etc., and to answer any questions council may have. The meetings are the fourth Thursday of the month and are held at the Greenfield Township Fire Station. The mayor asked for a council member to attend those meetings to keep the village informed. - We have a draft from the audit, everything seemed to be fine with it. Will let the council know when we receive the final audit.
- Carroll Business Association has started back up again. There is a meeting tomorrow at noon, at the Fillin Station.

Council member Linda Dattilo brought to the council's attention that a resident has complained several times about their trash not being picked up. Linda called Local Waste and was told the resident hadn't paid their bill. The resident called and found out that their bill had not been sent out to them and Local Waste had a stack of bills from several residents that had been returned from the post office. Linda called to confirm this information and found it to be true. Local Waste has no idea why the statements were returned to them. The mayor stated he will reach out to the village contact for Local Waste. Linda stated they are not picking trash up if dropped on the ground by the trashmen. The mayor said that there are cameras on the trucks, so if there is a problem and we know the address, Local Waste can verify any information.

Council member would like to schedule a Safety Committee meeting for next Thursday, June 28, 2022 at 7:00 p.m. that will be held at the Carroll Civic Center.

Council member Adam Tippett asked if there were any laws about ATV's being on the road, because he saw one the other night. The solicitor stated that they have to be licensed in order to be on the street. Adam also wanted to know if the J. Johnson property around 52 High St. had a permit. The building permit will have to go through Toole.
