- Pavement markings scheduled for September 17, 2021.
- Applied for American Rescue Act funds. The village will receive approximately \$29,644.00 this year, and the same amount the following year. The deadline to spend it is December 31, 2024.
- DLZ applied for the design of Phase III sewer through Water &
  Wastewater Infrastructure Grant in the amount of \$89,500.00. The village
  will need a 10% match for these funds. Monies from the ARPA grant can
  be used to pay for the 10% match. Having the design of the sewer
  complete will help us score better on other grant opportunities.
- The present sewer project is moving along slowly. The contractor is still waiting for the lift station to be delivered.
- Trick or Treat-MORPC recommendation is October 28, 2021.
- DLZ Engineering has received several inquiries from Fisher Homes concerning water and sewer availability in areas surrounding the village.
- Finance Committee needs to schedule meeting to discuss water and sewer rates for 2022, the water fund is very low on funds (reminder Fairfield County Utilities increases the village's rates by 3% every year).
- Village Clerk is still out of the office on medical leave. Have not heard when she will be returning to work. I applaud Crystal and Elaine for keeping the office functional during Mary's absence.
- Park Street will be closed October 2, 2021 for the Clum auction.
