Visitors Comments

Gary Silcott from DLZ gave an update on the phase 3 sewer project. He stated they have put in a request for a principal forgiveness loan for the village. It usually takes a few weeks to hear back. They also submitted an application for a grant through OPWC for the phase 3 sewer project. It will be around February, 2023 before they could hear back from OPWC.
