New Business

Council needed to decide between a 5% match or an 11% match towards the street grant. DLZ Engineering informed council that if funds are available, it would be better to do an 11% match over the 5% match. Sara from DLZ stated the more of a match the village can put forth gives more points towards getting the grants.

Council discussed and looked over the street fund. Adam Tippet made a motion to amend Resolution 2025-R-8 **A RESOLUTION AUTHORIZING THE MAYOR TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION (OPWC) STATE CAPITAL IMPROVEMENT AND/OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S), TO EXECUTE CONTRACTS AS REQUIRED, AND THE DECLARATION OF AN EMERGENCY**, to add the village will do the 11% match toward the grant, seconded by Kevin Rinehart, roll call was all in favor.

*Discussion by Adam Tippet stated that we can set the match, submit and we may or may not get the grant, but is best to do the 11%.

Will Burns wanted to just put out there that we need to start looking ahead for next year for a leaf machine, or something to replace what we currently have.

Kenny George stated that he has mentioned a salt spreader for smaller streets/some alleys. He stated James, Village Administrator, keeps pushing back on it. Kenny did say James looked at some options.

The tractor was brought up. The clutch is on its last adjustment and need to start thinking about replacing the tractor. Kevin Rinehart is going to get a contact to Kenny to see if they can look at it and give a cost on fixing the tractor, if it is even an option.

Will Burns asked about Derek VanGundy that helps James. Fiscal Officer Crystal Roberts stated she has not heard anything.
