**To:** Property Owners in the Village of Carroll Sanitary Sewer Phase 2 Project Area  
**Subject:** Sanitary Sewer Connections may now begin.

1. The sanitary sewers in your neighborhood have been accepted by the Village for operational purposes. Operational acceptance means that you may begin your service connection process immediately.
2. You may either perform the construction work yourself if you are an approved sewer contractor through the Fairfield County Health Department or use the services of a sewer contractor licensed with the Fairfield County Health Department (list attached). All service lines are at the home-owners expense.
3.
  - a. If you are a licensed sewer contractor in Fairfield County and choose to do the work yourself, you must first contact the Village of Carroll and obtain a license and a permit. At that time, you will also receive printed information that outlines the correct manner by which to make the connection. You are urged to read the manual and follow instructions carefully. Doing so will save you time and money.
  - b. If you choose to have a licensed sewer contractor do the work, you must make sure that they are licensed with the Fairfield County Health Department. To verify contractor licensing refer to the attached list of registered contractors from the Fairfield County Health Department. If you have questions about the attached list of registered contractors please call the Fairfield County Health Department at 740-652-2800. The contractor must then obtain the permit from the Village of Carroll to perform your installation. It is strongly recommended that you obtain at least two estimates before deciding on a contractor.
4. Regardless of whether you or your contractor installs the line and ties into the Village sewer system, you are responsible for correctness of the connections. If a contractor is doing your work, it is suggested that you review the printed information he received from the Village. The homeowner or homeowner's contractor is responsible for any cleanup or restoration that is needed due to the installation of the service lateral. Please contact the Village of Carroll at 740-756-4031 to schedule an inspection of your new service line.
5. **All material and connections must be inspected by the Village of Carroll and all tests must be successful before final acceptance of your connection will be given.**
6. 90 Days following this notice, the Village will cease to operate and maintain your individual Grinder Pump. It is highly recommended that you connect to the new Gravity System within this period of time.

8. Financial assistance may be available to those residents who qualify.  
If you own and occupy your home and are a low-income resident
  - a. The USDA provides financial assistance for this type of residential expense if you are unable to secure grant funds to cover your costs. You may contact Jordan Parson at 740-885-3286 or Kristen Hill at 740-885-3294.
  - b. Fairfield County Health Department also has Funds available for this type of expense. You can contact Rachel Moresea at 740-652-2823.
  - c. Fairfield County Community Action also has funds available for this type of expense. You can contact Randy Hunt at 740-653-4146.
9. We want to caution all residents to make sure that when you get estimates to make sure all contractors are bidding the same work. Work should consist of material and labor to install your 4-inch SDR 35 service line meeting the requirements of the Village of Carroll Manual for Sewer Service Installation. This work will include proper bedding of the pipe, air testing before completion and restoration of the excavated area.
10. All residents will be required as part of your on-lot sewer installation to properly abandon your existing on-lot sewer service. Be sure this cost is included in the quote from all sewer contractors.
11. If any residents see any Septic Haulers dumping septage into the Village sewer system, please contact the Village immediately at 740-756-4031. This is **ILLEGAL** and will cause operational problems within the sewer system and may result in higher costs to the residents of the project.

***DO NOT flush items through the sewer system even if they are marketed as “flushable”; ONLY human waste and toilet paper should be put into the system. Any other “flushable” or non-flushable items WILL CAUSE increased costs to operate the system and potential DAMAGE to system components. Property owners will be responsible for any blockage on their line from the right of way line to your house.***
